6. Superintendent's Report

- NYSED Advisory Committee: I have been asked by NYSED to be a member of a state advisory
 committee as a result of the work that is being conducted through our STLE Grant. This is a one-year
 commitment and involves participating in meetings, telephone conferences, conducting presentations,
 providing feedback on programs conducted throughout other school districts in the state and possible
 site visits.
- 2. CASDA Presentation: CASDA has contacted me and asked me to part of a presentation for a conference on December 2nd in Albany.

- 3. Solar Panels: All the required documentation for our solar panel project has been submitted to NYSED for review and approval.
 - a. 50 kW on the Main Building;
 - b. 22 kW on the Technology Building; and
 - c. 300 kW at the Bus Garage
- 4. Regional Superintendent's Conference Day: On October 10th the district participated in the first-ever Washington County Regional Superintendent's Conference Day (Fort Ann, Argyle, Fort Edward, Salem, Cambridge, Hudson Falls, and Granville). This event was funded through the STLE grant and the feedback from faculty has been positive. I am hoping that this can become a more regular occurrence as we seek to increase dialogue among the grade and department teachers in the county.
- 5. Mobile Cart: The district was able to obtain an additional mobile lab from BOCES, for no cost. Approximately 35 laptops have come off another lease and were available for use. The computers come with their own high-level cart that allows the district to push notifications and updates to all the computers even if they are turned off.
- 6. Policy Study: The district has partnered with Erie 1 BOCES for a Board of Education policy manual review. I have sent a copy of our policy manual to Erie 1 for review. After the review, BOCES send us templates for policies that are outdated, out of compliance, missing, etc. and then we revise the template per our district practices. In the upcoming months, there will be numerous policy revisions that the BOE will be voting on. Overall, this is a two-year process and, once completed, we will have a completely revised policy manual and then we can subscribe to an ongoing subscription for monthly updates and recommendations per new legislation. If possible, I would recommend that one or two BOE members review the policy prior to the BOE meeting for voting; creating an ad-hoc policy committee. I would recommend meeting at least a week prior to the BOE meeting to discuss the revised policies for the upcoming meeting.

- 9. New Business
 - 9.1 CPSE/CSE/504 Recommendations: The Board of Education accepted the recommendations of the CPSE/CSE Committee. Motion made by Mr. Smith and seconded by Mr. Fish. Approved 3-0.
 - 9.2 Resolution for Cooperative Energy Purchasing Service for Electricity: This is a cooperative agreement for the district that allows us to purchase electricity at a discounted rate. Even though the district is in the process of installing solar panels, the cooperative energy agreement is separate from USLE as this is our energy supply while the panels will act as an on-site generator of electricity, which will reduce the supply we purchase from the cooperative, but not eliminate it. The Board of Education adopted the proposed Resolution for Cooperative Energy Purchasing Services for Electricity.  - 9.3 Retirement: Superintendent's Secretary: Mrs. Marjorie Durling has submitted her letter of retirement from the district, effective December 31, 2014. - 9.4 Resignation: Teacher Aid: Mrs. Jennifer Parker has submitted a letter of resignation from the position of Teacher Aid, effective October 20, 2014. The Board of Education accepted Mrs. Parker's letter of resignation, effective October 20, 2014. Motion made by Mr. Smith and seconded by Mr. Fish. Approved 3-0.
- 9.5 Appointment: Teacher Assistant: The district is in need of a certified Teaching Assistant. During the summer and fall months, Mrs. Parker completed the NYS required certification process for a Level 1 Teaching Assistant. The Board of Education appointed Mrs. Parker to the position of Teaching Assistant, effective October 21, 2014. Motion made by Mr. Smith and seconded by Mr. Fish. Approved 3-0.
- 9.6 Bus BOND: At the 2014-2015 budget vote, the voters approved a proposition authorizing the purchase of a 66 passenger school bus, with a cost not to exceed \$114,000. Included within the Board packet is a Bond resolution, as prepared by our Bond Council, required Board approval. The Board of Education approved the Bond Resolution for \$114,000. (Voice Vote is Required) Motion made by Mrs. Thomas Voice Vote: Mr. Smith Yea, Mr. Fish Yea, Mrs. Thomas Yea
